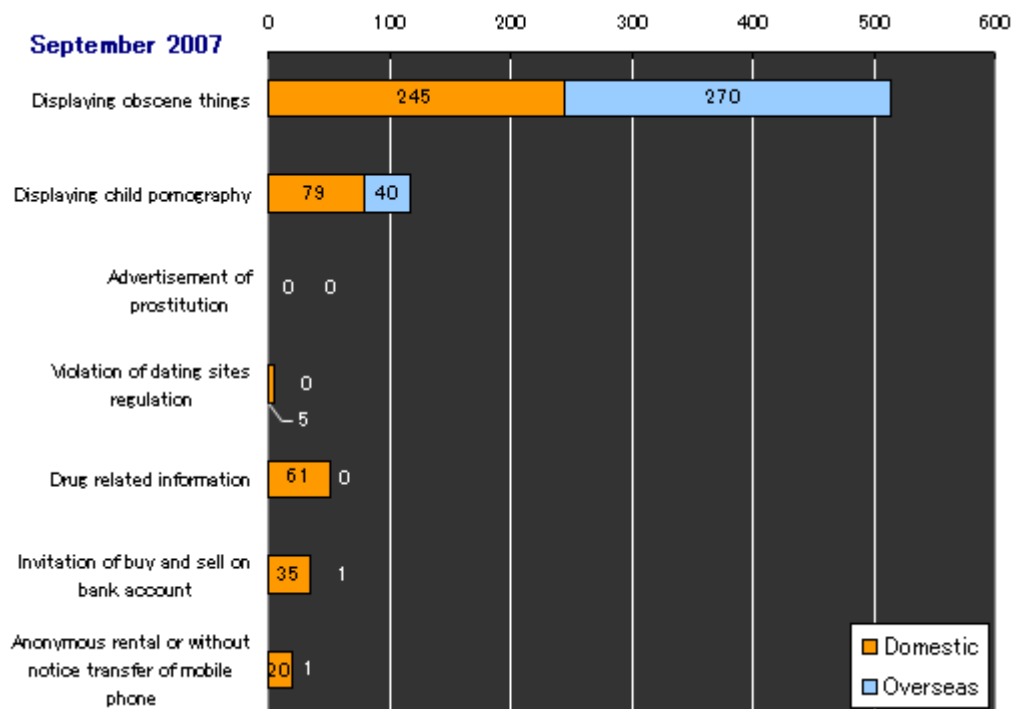

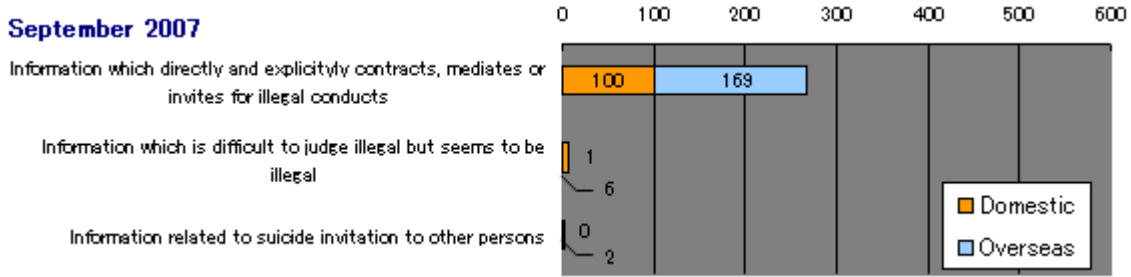

*Reports which were judged as harmful are sent to administrators of servers to request deletion of content unless the report contained illegal information and police stops forwarding for investigation and preservation of evidence. Some of reported content have been deleted before forwarding.
